



67° INTERNATIONAL VINTAGE RALLY CAR BARCELONA - SITGES — RULES —

Artº 1º. Organizers

Foment de Sitges, in collaboration with Reial Automòvil Club de Catalunya (RACC) and the Antic Car Club de Catalunya (ACCC), also with the support of the Council of Barcelona and Sitges, organize a Touristic-concentration called *67th International Vintage Rally Car Barcelona - Sitges*, to be celebrated the 05th, 06th and 07th of March 2025.

Artº 2º.-Jurisdiction

This Rally – Tour is organized under the rules that are set in this document, which are of compulsory observation and fulfilment.

Artº 3º.-Participants

Participants can solicitate the inscription if they are in possession of cars in well conditions and are included in the following articles 3.1 and 3.2:

- 3.1 **Época:** Cars whose year of construction is before to 31 of December 1920, will be aggregated following the article nº 4 (Group I, II and III).
- 3.2 **Vintage:** Cars built between 1st of January 1921 and the 31th of December 1928, article 4º (Group IV and V).
- 3.3 **Reserva:** The organization reserves the right of accepting any vehicle that could give some services for the Rally, although they won't be candidates for any prize.
- 3.4 **Admission:** **All participants must present their application form with 4 pictures of the vehicle (front, right side, left side and back)**, standard size (jpg for example) and updated, as well any kind of documentation and bibliography about the car (if possible).

The admission of this group won't be considered accepted without the final acceptance from the Organization and communication.

At the moment of completing the registration, ther should be specified the number of people attending the Saturday and Sunday meals. There wont be accepted any changes before the 15th of March 2025

- 3.5 **Plurality:** In order to preserve the plurality of the vehicle fleet, participation limits are established by make and model.
This limit is set at 7 cars/make and model. However, in the event that the vehicle to be registered is of a make and model that has already occupied the maximum number of seats, if the owner can prove that he has already participated previously, he may register the vehicle. The valid date to participate will be the date of manufacture of the vehicle, not the date of manufacture of the model
- 3.6 **Dress code:** Is a compulsory rule that all the participants and their accompanians will be dressed up following the style in relation with the age of the car that participate on Sunday the 06th.
- 3.7 **Kind of clothes:** improper or carnivalesque paraphernalia is strictly prohibited, or ridiculing entities or estates. Those who commit it would be automatically excluded from the event.
- 3.8 **Commercial vehicles:** Those that are not passenger cars could participate but not in the contest, previous acceptance by the Organization.
- 3.9 **Participation:** The number of vehicles won't exceed the number of 80 participants.

Artº 4º.-Groups

The vehicles participants will group ordered by its year of construction and not the year of its design or commercialization, in the following groups:

- Group I: Cars constructed until 31.12.1908

- Group II: Cars constructed from 1.1.1909 to 31.12.1914
- Group III: Cars constructed from 1.1.1915 to 31.12.1920
- Group IV: Cars constructed from 1.1.1921 to 31.12.1924
- Group V: Cars constructed from 1.1.1925 to 31.12.1928

Artº 5º.-Agenda

- 5.1 **Saturday the 05th of March: All contestants will be required to participate in all the different events taking place this day and remain in the Closed park available to commissioners.**

From 10:00 to 11:00 hours, the participants will arrive at the Centro Comercial Illa Diagonal de Barcelona and park their cars in the walk side in front of the Centro Comercial.

At 14:00 hours (aprox.), lunch for the participants (at the same location of the Centro Comercial).

Cars will be in exposition until 17:30 hours aprox.

Failure to present means exclusion.

- 5.2 **Sunday the 06th of March:**

From 8:30 hours until 9:30 hours, Arrival of all vehicles and their occupants to the Plaza de Sant Jaume, and as directed by a Commissioner will park on site and ordered as indicated. (It is imperative that the contestants park properly their vehicles before 9:45 so that different juries could fulfill their obligations. If contestants are later than this deadline, vehicles and occupants were excluded from the qualifications and awards that could correspond them).

From 9:00 to 10:15 hours, in the Gothic Gallery of the City Council will be served typical «Xocolatada», offered by Jolonch Chocolates and the City Council of Barcelona. (To access will be compulsory to show the ticket entrance).

At 10:15 hours, drivers and passengers will get into their cars and at the speakers sign will start their engines following the instructions of the Race director.

At 10:30 hours, Official Departure of the Caravan with older vehicles first. Exit Plaça de Sant Jaume, Ferran, Rambles, Plaça Catalunya, Ronda Universitat, Sepulveda, Avda. Paral·lel, Plaça Espanya, Gran Vía, passatge Marçal (L'H), Rambla de Badal, Carrer Santa Eulalia, Carrer Enric Prat de la Riba, Carrer Barcelona, Carretera de l'Hospitalet, Av. de la Fama, Carrer Tirso de Molina, Avda. del Baix Llobregat, C-245 Direcció Sant Boi, Sant Boi, Viladecans, Gavà, Castelldefels to Castelldefels Platja and the C- 246 by Botigues of Sitges to the shores of Garraf, arrival at 12.30).

- 5.3 **Parade in Sitges:** At 12.30 hours approx. parking in the closed park La Fragata and official lunch.

- 5.4 **Concours d'Elegance:** To this end, passengers will arrive on foot and go parading grouped by vehicle in front of the Jury classifier.

- 5.5 **Trophies:** After lunch we will proceed to the distribution of trophies according to the decision of the Juries, which are final.

- 5.6 **End of the Rally:** Around 17:30 hours Rally will terminate.

- 5.7 **Monday 07th of March:**

Touristic route will be held through the Garraf – Penedès roads. Route will be confirmed shortly. This touristic route will only take place if there are a minimum of participants inscribed, for that we ask for interest. It is not included in the registration fee. Shortly will be informed final route and price.

Artº 6º.-Circulation

Respect the Road Code: Contestants are obliged to respect and comply with the rules Road Code and obey the instructions they receive from the various municipal police forces and the Mossos d 'Esquadra.

- 6.1 Pace car: It is strictly forbidden to exceed at any time the pilot test car, this would mean expulsion.**
- 6.2 Route: Whatever that during the itinerary will go through several densely populated urban populations, is welcome step up their prudence and do not intend to make unnecessary and dangerous overtaking between competitors.**
- 6.3 Garraf shores Castelldefels - Sitges: Because of the difficulty of the track and to the requirement that the closing direction Castelldefels-Sitges has the least possible duration, the Caravan will reach the coast as compact as possible, so the Pilot car will carry neutralizing. At the beginning of the Costas, Pilot car will accelerate so that each participant can raise as much as possible according to the needs of its vehicle.**
- 6.4 Garraf shores Sitges-Castelldefels: Should note that although the 'Mossos d'Esquadra' will stop all vehicles in this sense, can always be someone who cannot attend the indication given by the 'Mossos d'Esquadra' or an ambulance, etc. who for various reasons do not make the correct arrest.**
- 6.5 Documentation: Each vehicle must be in possession of documentation, insurance RC. and precise permissions for driving on Spanish roads.**

Artº 7º.- Trailers and Breakdowns:

The entry of any trailer in different parks closed is strictly prohibited, as well as accompanying the caravan go.

- 7.1 is not allowed ride integrated in the Caravan driven by any type of trailer.
- 7.2 If a contestant is stopped by a vehicle breakdown during the journey and could repair it, should seek to rejoin the caravan on their own.

Artº 8º.- Registration:

Only applications for registration received through the online form and, occasionally, through the official form duly filled in and economically completed in all its terms will be accepted. During the collection of documentation on Saturday 05, the official document will be signed:

8.1 Closing registration: At 21:00 hours of the 15th of March 2025

8.2 Vehicle pictures: For all the vehicles (see Artº 3.4). Rule that also affects any other vehicle even it has participate in past editions.

8.3 Registration fees: Registration fees for vehicle are as follow:

Registration fee includes:

- To participate in the 67th International Vintage Rally Car Barcelona – Sitges.
- Lunch for two persons Saturday the 05th of March.
- Breakfast for all the car occupants on Sunday the 06th in the City Council of Barcelona.
- Appetizer for all the car occupants in the Port Aiguadolç de Sitges on Sunday the 06th of March.
- Official lunch for two persons on Sunday the 06th of March.
- Parking in la Illa Diagonal the night of Saturday the 05th of March.
- Cranes and trailers parking in the Garrofer Camp in Sitges the 04th, 05th, 06th and 07th of March.
- Parking in Sitges Friday 04th and Sunday 06th of March.
- Transport service Barcelona – Sitges for all the occupants hosted in Sitges the 05th of March.
- Transport service Sitges - Barcelona - Sitges for all the occupants hosted in Sitges the 06th of March.
- Emergency Crane service along the route Barcelona - Sitges.

If you are unable to attend any event, it must be notified the organization before the 15th of March. In any annulment, either lunch or registration after this date, the refund will not be applicable.

In case of cancelling the event for major causes not originated by the organization, the registration fee will be returned, except a 10% for structural expenses.

8.4 **Tickets:** Each vehicle entered and accepted, to withdraw its documentation will receive **two tickets** to all official acts of the Rally.

8.4.1 **Extra tickets:** The contestants, until the ticket limit, could apply for as many tickets as necessary for the rest of the passengers of their car, for the lunch of Saturday the 05th at **50€/adult** and **25€/kids** and for the Sunday the 06th lunch at **60€/adult** and **25€/kids**.

8.4.2 **Acceptance:** Any application will not be considered firm until we receive full payment of the amount and thereof will be considered valid once accepted by the Organizing Committee.

8.4.3 **Access:** Entry only be allowed to all official acts by the presentation of the ticket.

8.4.4 **Exclusion:** The organization reserves the right to reject any application for registration without stating reasons. Also it is empowered to prohibit the departure of any vehicle whose occupants do not comply with the Artº 3 mainly in paragraphs 3.5, 3.6 and Artº 9.

Artº 9º.-Advertising:

Is strictly prohibited any advertising on vehicles and / or clothing of the participants, except provided by the organization that should be placed as mandatory indications.

Artº 10º.-Closed Park Verification:

On Saturday March 05th from 10:00 hours, the drivers with their vehicles must compulsorily submitted to the RACC accreditation office and Foment de Sitges, in the La Illa Diagonal shopping centre in Barcelona where they will be given , side plates and numbers for the vehicle.

10.1 Participants with their vehicles will be available to the Organization to participate in the events planned and communicated in an annex to this Regulation.

10.2 **Removal of vehicles:** All vehicles exposed in the Closed Park placed before indicated, shall be removed following the instructions thereof and are valid as Regulation

10.3 **Exclusion classification:** Vehicles not submitted to verification at the Closed Park will be automatically excluded from classification.

Artº 11º.-Classifications:

The following classifications are established:

11.1 **Costumes:** A classification for all the occupants of each vehicle more properly attired relative to the time of his vehicle, according to the Artº3º, section 3.5

11.2 **Competition:** To be included in the classification and eligible for prizes, is indispensable condition that the entry in Sitges, is made with the vehicle running and on their own.

Artº 12º.-Trophies:

The following trophies will be awarded:

12.1 **Costumes:** Trophy for the top three finishers, may be increased the number of winning trophies according to the Organization.

12.2 **Other trophies, or extension of the same:** could take place depending on the amount held by the Organization and the discretion of the Juries classifiers.

12.3 **Jury:** The Jury for the 12.1 classification shall be appointed by the Foment de Sitges.

12.4 **Verdict:** The verdict given by each jury is final and made public at the end of the official lunch.

Artº 13º.-Insurance:

Participants must have covered the mandatory liability insurance established by the current law.

- 13.1 **Liability:** Participant in their own name and that of his companions, and in case of accident excludes all liability to the organizers of the Caravan and renounces bring claims against them.

Artº 14º.-Participant's numbers:

The numbers that participating vehicles necessarily hold at the front, are merely for identification purposes by different juries established in the Closed Parks and at different points along the route, and in any case for the purposes of competition.

The organization reserves the right to modify, if necessary, any item of this regulation.
